# **COMMUNITY GRANTS SUPPORT**

### **Purpose**

Diggers Services Club has made available and invited you to apply for a funds, donations or goods that can assist organisations to achieve their service to the community. This can include services at the Club such as function rooms to hold meetings or events.

### **Guidelines**

Applicants must be able to demonstrate that they provide services to the residents of Logan City and/ or the Service or Ex Service Community.

### **Eligible Organisations**

Ex-service and Service related, Sporting Groups, Educational bodies and Community Groups based in Logan City. Private Citizens and individuals are not eligible.

### **Eligible Activities**

Services, works, projects and activities are eligible for consideration.

#### **Exclusions**

- 1. Recurring operating costs of the applicant eg. Wages, utility debts, administration costs and debt repayment.
- 2. Food hampers.
- 3. Other requests of a nature that can be met by other social and welfare agencies.
- 4. Contributions to individuals.

#### **Assessment Criteria**

- 1. (a)Satisfactory completion of the application form plus questionnaire and all relevant inclusions as requested. Failure to provide all relevant information will result in rejection of the application.
  - (b)Be an eligible entity/organisation and deliver quality outcomes to residents of Logan City.
- 2. (a)All applications will be assessed by a committee and each considered on its own merits.
  - (b)Applicants selected by the committee to progress may be required to provide additional information.

## Application Details- Open 1st March 2023 - 15th June 2023

### **Acquittal Form**

The Acquittal Form is a formal notification advising that funds provided have been used to fund your project in accordance with your grant application. It is part of Diggers Services Club grant conditions that successful applicants are required to submit an Acquittal Form within 30 days of receipt of your grant.

Failure to meet these conditions may exclude you from consideration for further funding requests or grants.

Note: Diggers Services Club reserve the right to request documentation that supports that all funds have been utilised in accordance with information provided in the Grant Application
